The authors regret an error in the fourth paragraph of the Methods section. This should read as follows:

Whole-body insulin-stimulated glucose uptake (M-value) was measured with a hyperinsulinaemic–euglycaemic clamp after fasting overnight. Insulin (Actrapid, 100 U/ml, Novo Nordisk, Bagsvaerd, Denmark) was infused at a 160 mU/m²/min body surface area/min rate during the first 4 min, at 80 mU/m²/min during minutes 4–7,

and thereafter at $40~\text{mU/m}^2/\text{min}$. Four minutes after starting insulin infusion, 20% glucose infusion was started. The rate was adjusted according to plasma glucose concentration measured every 5-10~min. M-value (μ mol/kg/min) was calculated in 20-min intervals from steady-state glucose values. Fasting insulin and HOMA-IR were determined as surrogate markers of insulin sensitivity as described
